Jose Licea Annexation to

WHEREAS, a proposal for the proposed annexation of certain territory to the &xxxxx Calpella County Water District District has been filed with the Executive Officer of this Local Agency Formation Commission pursuant to Title 5, Division 3, commencing with Section 56000 of the Government Code; and,

WHEREAS, the Executive Officer has reviewed the proposal and prepared a report, including his recommendation thereon, the proposal and report having been presented to, and considered by this Commission; and,

1. The proposal, being identified in the files of the Mendocino County Local Agency Formation Commission as File No. 88-5 be and the same is hereby approved/densited subject to the following conditions and terms:

That the map be corrected to satisfy the County Surveyor prior to the Calpella County Water District annexing the territory.

2. The boundaries, as set forth in the proposal, are hereby approved as submitted.

Set forth in Exhibit "A" attached and by this related and proposal are incorporated herein.

- 3. The territory includes $\frac{44}{}$ acres, is found to be uninhabited/inhabited, and is assigned the distinctive short form designation: Jose Licea Annexation to Calpella County WAter District
- 4. Thex Kity for Calpella County/Water
 District Board of Directors is designated as the conducting authority and is hereby authorized to conduct subsequent proceedings in compliance with this resolution.
- 5. The Executive Officer is hereby authorized and directed to mail certified copies of this resolution as provided in Section 56853 of the Government Code.
