RESOLUTION OF THE MENDOCINO COUNTY LOCAL AGENCY FORMATION COMMISSION APPROVING FORMATION OF THE SANEL VALLEY FIRE PROTECTION DISTRICT AND ADJUSTMENT OF THEIR SPHERE OF INFLUENCE

WHEREAS, an application for formation of a special district to be known as Sanel Valley Fire Protection District was duly filed by the County of Mendocino Board of Supervisors as lead agency by Resolution No. 97-003 dated January 7, 1997 in accordance with Health & Safety Code Sections I38I5 et seq., which further set forth a finance mechanism for transfer of a special tax per parcel subject to voter approval at the regular election of June 3, 1997 in an amount not to exceed \$43 per unit, which was later amended by the Mendocino County Board of Supervisors by Resolution No. 97-030 dated March 4, 1997 to no more than \$35 per unit special tax and further called for said election for the special tax measure as well as setting the Gann limit for \$150,000 which application was received by the Mendocino County Local Agency Formation Commission together with supporting documents required by rules of said Commission on April 15, 1997; and,

WHEREAS, said application has been processed pursuant to the provisions of Division 3, Title 5 commencing with Section 56000 of the Cortese - Knox Local Government Reorganization Act of 1985, State of California; and,

WHEREAS, at the times and in the form and manner provided by law, said Executive Officer has given notice of public hearing by this Commission upon said application and prepared a report which was delivered at said hearing, including her recommendations thereon, with said application and report having been presented to and considered by this Commission; and,

WHEREAS, a public hearing was held by this Commission at a special meeting held on May 22, 1997 as continued from the noticed Public Hearing scheduled for May 5, 1997; and,

WHEREAS, at such hearing this Commission heard and received all oral and written protests, objections and evidence which were made, presented, or filed, and all persons present were given the opportunity to hear and be heard in respect to any matter relating to said application and report; and

WHEREAS, at such hearing this Commission set forth several conditions that required corrections, clarifications and/or modifications to the proposal to be completed some prior to action by the Conducting Authority and others prior to allowing the issue to go before the voters for the November ballot.

NOW THEREFORE, BE IT RESOLVED, that the formation of a special district to be known as the Sanel Valley Fire Protection District being identified in the files of the Mendocino County Local Agency Formation Commission as File No. L95-4 be the same and is hereby conditionally approved by the Mendocino County Local Agency Formation Commission with the following findings:

- 1. The final boundaries of this district formation are as identified in the legal description attached as Exhibit A and map as Exhibit B of this resolution.
- 2. Resolution No. 97-008 has been executed by the Mendocino County Board of Supervisors accepting a zero tax exchange agreement of property tax revenues relating to the formation of the new Sanel Valley Fire Protection District.
- 3. A Property Tax issue collected by the Hopland Public Utilities District was acknowledged by the Commission as having been executed by the Hopland Public Utilities District for transfer to the new Sanel Valley Fire Protection District.
- 4. The Mendocino County Board of Supervisors conducted the CEQA process and made a finding of a Negative Declaration which Notice of Determination was recorded on January 23, 1997 and was accepted by the Commission.
- 5. Action on this proposal and forwarding to the Conducting Authority is subject to passage of the special tax and Gann limit scheduled for voter approval on June 3, 1997.
- 6. The following terms and conditions of approval by the Commission shall be as follows:
 - a. All issues and provisions adopted in the County of Mendocino's Resolution No. 97-003 and 97-030, including all exhibits, and application package, as referenced hereto and incorporated as though set forth herein, shall be set forth as LAFCO conditions of approval of this district formation.
 - b. All required water service agreements, including, but not limited to the Russian River Estates and Retech shall be completed no later than July 14, 1997.
 - c. The overlap of Sphere of Influence between the proposed district and Anderson Valley Community Services District shall be resolved to the satisfaction of both parties prior to action by the Conducting Authority. The LAFCO Fire District Sphere of Influence map is to be corrected and filed at the LAFCO office, with copies to both parties.

- d. The discrepancy regarding the number of registered voters in the proposed district territory is to be resolved and the outcome relayed to County Elections and the Assessor's Office for consistency, prior to going to the November ballot.
- e. The question of formation of the Sanel Valley Fire Protection
 District shall be presented to the voters for the November 1997 ballot,
 with the transfers of the special tax and Gann limit to be further noted
 for the voter awareness. The Impartial Analysis shall be prepared
 by the Executive Officer with the assistance of County Counsel.
- f. The Commission hereby designates the Mendocino County Board of Supervisors as the conducting authority for further proceedings pursuant to Health & Safety Code section I3823, in this case, calling for voter election of the formation, with reference to the transfer of the special tax and Gann limit to the new district if formation is successful.
- g. Costs of the election shall be in accordance with Health & Safety code section I3887.
- h. Election of District Board Members shall be in accordance with section I3837 of the Health & Safety Code.
- Upon success of the election and formation, all agreements, JPA's, and ordinances noted in the County of Mendocino's application - File L95-4, shall be executed.

BE IT FURTHER RESOLVED AND ORDERED that the Executive Officer of said Commission is hereby authorized and directed to forward copies of this Resolution in the manner as provided by law.
