CONDITIONS

- 1. Accept the Negative Declaration as adopted by the Redwood Valley County Water District, and file with the County Clerk.
- 2. Approve this annexation and authorize the District to proceed without public hearing pursuant to Section 56837 of the Government Code, with the following conditions:
 - A. That a Master Tax Exchange Agreement is executed by the Redwood Valley County Water District, or a Board of Supervisors Resolution verifying the zero tax exchange be executed prior to the filing of the Notice of Completion.
 - B. County Counsel is to review the Court Order as it pertains to domestic and irrigation use and if there is a conflict with the information presented by Staff, this proposal is to be brought back to LAFCO for reconsideration.

- 2. The boundaries, as set forth in the proposal, are hereby approved.
- 3. The territory includes 40.56 acres, and is found to be uninhabited/xxxxxxxxxxxx, and is assigned the distinctive short form designation: Gabrielli Winery Annexation to the Redwood Valley County.
