- 3. The territory includes 25,350.4 acres, and is found to be warmharkted/inhabited, and is assigned the distinctive short form designation: Ukiah Valley Fire District Annexation, File #90-6
- 4. The Ukiah Valley Fire District is designated as the conducting authority and is hereby authorized to conduct subsequent proceedings in compliance with this resolution.
- 5. The Executive Officer is hereby authorized and directed to mail certified copies of this resolution as provided in Section 56853 of the Government Code.

CONDITIONS OF APPROVAL

UKIAH VALLEY FIRE DISTRICT ANNEXATION - FILE #90-6

- Extension of services to the proposed areas appear to be logical as service is already being delivered by the UVFD.
- Accept the Categorical Exemption adopted by the District and file with the County Clerk.
- 3. Adjust District annexation boundaries to meet the current adopted Sphere of Influence boundaries with no overlap into the Hopland Public Utility District's Sphere of Influence.
- 4. Adjust map and legal description to comply with #3 above to the satisfaction of the County Surveyor prior to action by the Conducting Authority.
- 5. The City of Ukiah will continue to provide fire protection service under its existing contract with Vichy Springs Investors Group and the latter's successor in interest; and the Ukiah Valley Fire District will not provide service to the Vichy Springs area as long as such existing contract is in effect, and will not include this area in the assessment process; and the Ukiah Valley fire District will provide service to the Vichy Springs area and assess accordingly only after the expiration of such existing contract or its earlier cancellation by its parties. In such event, the Ukiah Valley Fire District shall notify in writing the Local Agency Formation Commission of commencement of service to the Vichy Springs area.
- 6. Designate the UVFD as the Conducting Authority to conduct further proceedings pursuant to Government Code Section 57000 et. seq., and to hold a protest hearing for the benefit assessment within 90 days from action of the Commission.
- 7. The application will be held by the Executive Officer until the results of the benefit assessment hearing conducted by the District are determined to be successful. If the results of the hearing are not successful, the annexation shall not be filed as complete.

- 8. If approval and benefit assessment passage takes place, the District shall pursue an increase in their allowable Prop 4 spending cap in accordance with the appropriate Government Codes for Fire District benefit assessment.
- 9. District is to contact the County Planning Department and update the District boundaries to be in compliance with the County's General Plan.
- 10. District is to work with the Mendocino County Sheriff's Department in updating their 911 response system prior to filing the application with the State Board of Equalization.
