RESOLUTION MAKING DETERMINATIONS

ON THE PROPOSAL DESIGNATED AS:

Kauffman Annexation to the Ukiah Valley Fire Protection
District

(LAFCO FILE NO. 78-7)

WHEREAS, the ~~Municipal Organization Act of 1977~~ District Reorganization Act ⁵⁶¹³⁰ ~~35100~~, in Sections ~~35100~~ ⁵⁶¹³⁰ et. seq. of the Government Code, does establish certain preliminary procedures which shall apply to proposals such as Kauffman Annexation to the Ukiah Valley Fire Protection District, and

WHEREAS, the Preliminary Proceedings were initiated when the Executive Officer of the Commission accepted for filing the subject application and issued a Certificate of Filing on 25 January 1979.

NOW, THEREFORE, BE IT RESOLVED that:

The short term designation for the affected territory shall be Kauffman Annexation to the Ukiah Valley Fire Protection District; and

The affected territory shall be bounded as described in the attached Legal Description; and

The affected territory is uninhabited as defined by ⁵⁶⁰⁷⁴ ~~35038~~ Section ~~35038~~ of the Government Code; and Notice and hearing on this proposal are not required as per Section 56261; and

The Executive Officer did set the proposal for hearing on N/A and did give notice at the time and in the manner prescribed by law; and

The Executive Officer did review the application filed with him and did prepare a report, including his recommendations, thereon; and

Pursuant to the California Environmental Quality Act of 1970,
the Commission has found that consideration of the environmental
impacts of this proposal was included in the Negative Declaration
previously issued by the County of Mendocino for parcel subdivision

#P 3-77 _____; and

The Commission, at their meeting(s) on 5 March 1979,

oral and written protests, objections or evidence which were
made, presented, or filed; and considered the report of the




