RESOLUTION MAKING DETERMINATIONS

ON THE PROPOSAL DESIGNATED AS:

Orchard Avenue South Detachment from Ukiah

Valley Fire Protection District

(LAFCO FILE NO. 79-4)

WHEREAS, the District Reorganization Act, Government Code 56,000 et. seq. ~~Municipal Organization Act of 1977~~, in Sections ~~35100-~~ 35100- et. seq. of the Government Code, does establish certain preliminary procedures which shall apply to proposals such as Orchard Avenue South Detachment from the Ukiah Valley Fire Protection District, and

WHEREAS, the Preliminary Proceedings were initiated when the Executive Officer of the Commission accepted for filing the subject application and issued a Certificate of Filing on 15 June 1979.

NOW, THEREFORE, BE IT RESOLVED that:

The short term designation for the affected territory shall be Orchard Avenue South detachment from Ukiah Valley Fire Protection District; and

The affected territory shall be bounded as described in the attached Legal Description; and

The affected territory is uninhabited as defined by Section ^{56,074} ~~35038~~ of the Government Code; and

The Executive Officer did set the proposal for hearing on July 2, 1979 and did give notice at the time and in the manner prescribed by law; and

The Executive Officer did review the application filed with him and did prepare a report, including his recommendations, thereon; and

Pursuant to the California Environmental Quality Act of 1970,
the Commission has accepted the Negative Declaration of Environmental
Impact adopted on November 15, 1978 by the Ukiah City Council (the lead
agency). _____;and

The Commission, at their meeting(s) on July 2, 1979,
held a public hearing as noticed, and heard and received all
oral and written protests, objections or evidence which were
made, presented, or filed, and considered the report of the
Executive Officer and the plan for providing municipal services
to the territory.

The proposed Orchard Avenue South Detachment from Ukiah Valley
Fire Protection District

is approved with the following amendments


