## RESOLUTION OF THE LOCAL AGENCY FORMATION COMMISSSON OF MENDOCINO COUNTY MAKING A SPHERE OF INFLUENCE DETERMINATION FOR THE MENDOCINO COAST RECREATION AND PARK DISTRICT (MCRPD)

## August 4, 2008

WHEREAS, pursuant to Government Code Sections 56378, 56425 and 56430 LAFCO initiated a combined Sphere of Influence (SOI), Municipal Service Review (MSR) and Maximum Service Area Report for the Mendocino RPD; and

WHEREAS, the Executive Officer pursuant to G. C. Section 56663 set August 4, 2008 as the hearing date for the Commission's review of the combined Report, the annexation request and the SOI determination; and

WHEREAS, RCFPD sought the Commission's approval to annex the balance of the territory within its historical SOI and upon annexation is requesting that its SOI be coterminous with its new boundaries; and

**WHEREAS**, if the annexation is not approved by the Commission or the voters, MCRPD is requesting that their SOI be the proposed annexation territory; and

WHEREAS, the Commission called for and held a hearing on the combined Report, the annexation request and SOI request on August 4, 2008, and at the hearing, this Commission heard and received all oral and written protests, objections and evidence which were made, presented or filed, and all persons present were given an opportunity to hear and be heard with respect to the MSR report; and

WHEREAS, the Local Agency Formation Commission of Mendocino County based on the findings, discussions and conclusions set forth in the combined SOI/MSR/MSA Report which is incorporated herein by this reference and information received at the noticed public hearing for this item on August 4, 2008 did determine and approve the combined SOI/MSR/MSA Report and the determinations within and did approve the annexation as requested by MCRPD.

WHEREAS, this Commission has fulfilled its obligations as a Lead Agency as defined by the California Environmental Quality Act and has reviewed and considered the Negative Declaration and Initial Study prepared by the Executive Officer and pursuant to Section 15096(g)(1) of the State CEQA Guidelines certifies that there are no changes or alterations in the project that can be made upon LAFCO approval to mitigate any impacts identified in the environmental review that are in the jurisdiction of LAFCO; and

NOW THEREFORE, the Local Agency Formation Commission of Mendocino County based on the findings, discussions and conclusions set forth in the approved combined Report and information received at the hearing for this item on August 4, 2008, DOES HEREBY DETERMINE AND APPROVE that the SOI for the District shall be coterminous with the District's legal boundaries as approved on August 4, 2008 or shall be the same territory if the annexation is not approved by the voters.
