RESOLUTION OF THE LOCAL AGENCY FORMATION COMMISSION  
OF MENDOCINO COUNTY MAKING DETERMINATION AND APPROVING  
THE SLAUSON ANNEXATION TO THE MENDOCINO CITY COMMUNITY  
SERVICES DISTRICT

RESOLVED, by the Local Agency Formation Commission of Mendocino County, State of California, that

WHEREAS, a proposal for the annexation of certain territory to the Mendocino City Community Services District in the County of Mendocino has been filed with the Executive Officer of this Commission pursuant to Title 5, Division 3, commencing with Section 56000 of the Government Code; and

WHEREAS, the Executive Officer has reviewed the proposal and prepared a report, including her recommendations thereon, the proposal and report having been presented to and considered by this Commission; and

WHEREAS, it has been determined to the satisfaction of the Commission that all owners of land included in the proposal consent to this annexation; and

WHEREAS, the Commission accepts the Negative Declaration as adopted by the Mendocino City Community Services District; and

NOW, THEREFORE, the Local Agency Formation Commission of Mendocino County DOES HEREBY RESOLVE, DETERMINE AND ORDER as follows:

1. The proposal is approved.
2. The boundaries, as set forth in the proposal, are hereby approved as submitted and are as described in Exhibit A attached hereto and by this reference incorporated herein.
3. The territory includes 1.27 acres, is found to be uninhabited and is assigned the following distinctive short term designation: Slauson Annexation to the Mendocino City Community Services District, File #93-1.
4. The Mendocino City Community Services District is designated the conducting authority, and the Board of Directors of the Mendocino City Community Services District is hereby authorized to conduct subsequent proceedings in compliance with this resolution, which proceedings may be conducted without notice and hearing or election or both.
5. The Executive Officer is hereby authorized and directed to mail certified copies of this resolution as provided in Section 56853 of the Government Code.

The foregoing resolution was introduced by Commissioner Clark, seconded by Commissioner Wasserman and carried this 3rd day of May, 1993, by the following roll call vote:

EXHIBIT "A"

SLAUSON ANNEXATION TO THE MENDOCINO CITY COMMUNITY SERVICES DISTRICT.

All that certain real property situate in the County of Mendocino, State of California being a portion of Section 29, Township 17 North, Range 17 West, Mount Diablo Base and Meridian described as follows:

Beginning at the Northeast corner of the intersection of Little Lake Road (County Road #408) and Gurley Lane (County Road #407Z) said point of beginning being 60 feet Easterly of the Southeast corner of the Gurley lot, and said point of beginning also being on the boundary of the Mendocino City Community Services District; thence North along the East line of said Gurley Lane, and along said District boundary, 166.43 feet; thence leaving said East line of Gurley Lane and said District boundary East, at right angles, 296.12 feet; thence South, at right angles, 208.58 feet to a point on the North line of Little Lake Road; thence along said North line North 81° 54' West, 299.10 feet to the point of beginning.
