RESOLUTION OF THE MENDOCINO COUNTY LOCAL AGENCY FORMATION
COMMISSION MAKING DETERMINATIONS AND APPROVING THE

PAVLOVIC ANNEXATION TO THE CALPELLA COUNTY WATER DISTRICT

WHEREAS, a proposal for the proposed Pavlovic
annexation to the Calpella County Water District
has been filed with the Executive Officer of this Local Agency
Formation Commission pursuant to Title 5, Division 3, commencing
with Section 56000 of the Government Code; and,

WHEREAS, the Executive Officer has reviewed the proposal and
prepared a report having been presented to, and considered by
this Commission; and,

WHEREAS, it has been determined to the satisfaction of this
Commission that all owners of land included in the proposal
consent to this annexation; and,

WHEREAS, this Commission called for and held a public
hearing on the proposal on August 5, 1991 and at the
hearing this Commission heard and received all oral and written
protests, objections and evidence which were made, presented or
filed, and all persons present were given an opportunity to hear
and be heard with respect to this proposal and the report of the
Executive Officer.

NOW, THEREFORE, the Mendocino County Local Agency Formation
Commission DOES HEREBY RESOLVE, DETERMINE AND ORDER AS FOLLOWS:

1. The proposal, being identified in the files of the
Mendocino County Local Agency Formation Commission as File No. 91-2
be and the same is hereby approved/denied subject to the
following conditions and terms:

PAVLOVIC ANNEXATION TO THE CALPELLA COUNTY WATER DISTRICT

CONDITIONS

1. Find that the Certificate of Filing dated March 11, 1991, was overturned by Commission action of April 1, 1991, and the Certificate of Filing dated July 17, 1991, supersedes the filing of March 11, 1991, and is in force.
2. Accept the Negative Declaration as adopted by the Calpella County Water District on July 10, 1991, and file a Notice of Determination with the County Clerk.
3. Application is conditionally approved for annexation pursuant to the terms and conditions set forth in Exhibit B of Resolution #91-05 as adopted by the District on July 10, 1991.
4. By resolution of this Commission, approve the annexation with the terms and conditions identified and designate the Calpella County Water District as the Conducting Authority to proceed without a public hearing pursuant to Government Code Section 56837.

2. The boundaries, as set forth in the proposal, are hereby approved.

3. The territory includes 61 acres, and is found to be ~~uninhabited/uninhabited~~, and is assigned the distinctive short form designation: Pavlovic Annexation to the Calpella County Water District, File #91-2


4. The Calpella County Water District is designated as the conducting authority and is hereby authorized to conduct subsequent proceedings in compliance with this resolution.

5. The Executive Officer is hereby authorized and directed to mail certified copies of this resolution as provided in Section 56853 of the Government Code.


