RESOLUTION NO. 68- 5

AMENDING RESOLUTION NO. 68-3 APPROVING
DETACHMENT OF TERRITORY FROM
LITTLE LAKE FIRE PROTECTION DISTRICT

Designated as File No. 68-1, Detachment
from Little Lake Fire Protection District

The following resolution is now offered and read:

WHEREAS, an application of the Brooktrails Resort Improvement District for the detachment of territory from the Little Lake Fire Protection District was filed and has been processed pursuant to the provisions of Division 1, Title 6, of the Government Code of the State of California;

WHEREAS, after notice and hearing upon the application as provided by law, Resolution No. 68-3, A Resolution Approving Detachment of Territory from Little Lake Fire Protection District was adopted by this Commission;

WHEREAS, this Commission is of the opinion that said resolution should be amended in the following and other respects:

a. The finding specified in Section 56271 of the Government Code, the uncontradicted evidence in support of which was included within the application and was before the Commission at the hearing, should be made, and the Commission should perform the other functions stated in such section, and

b. Condition No. 1 should be deleted inasmuch as a satisfactory map was filed with the application, and the map referred to in said resolution relates to territory not included within the territory involved in the proposed detachment, which it may or may

not be desirable to have detached from the applicant district depending upon the outcome of litigation in progress;

NOW, THEREFORE, IT IS HEREBY FOUND, DETERMINED and ORDERED that the ordering paragraphs of the said resolution be and they are hereby deleted, and the following substituted therefor:

1. That the territory proposed to be detachment be designated in the files of the Mendocino County Local Agency Formation Commission as File No. 68-1, Detachment from Little Lake Fire Protection District;

2. That said territory is uninhabited as such term is defined in Division 1 of Title 6 of the Government Code.

3. That the application for detachment of such territory from the Little Lake Fire Protection District be, and it is hereby, approved.

4. That the Little Lake Fire Protection District be the conducting district with respect to further proceedings under the detachment application and the Board of Directors thereof be, and it is hereby, directed to initiate detachment proceedings in compliance herewith.

5. That the Executive Officer of this Commission mail certified copies of this resolution as provided by Section 56272, Government Code.


